END OF TERM "SHARES"

Classes for ages 13 and under culminate in informal presentations by the students in the class, called "Shares". Shares are presented at the end of each term. These presentations are meant to be intimate to create a supportive and comforting environment to celebrate each student's creativity, growth, and achievements. For that reason, attendance is limited. Please mark your student's final share on your calendar so you can plan to attend. More details will be provided by the class instructor closer to the final day.

CLASS EXPECTATIONS & PROCEDURES

ATTENDANCE

Students are expected to commit to class attendance for the full semester. Our curricula are cumulative and structured to build upon each class; weekly attendance is necessary to be accountable to one another as part of an ensemble and work towards common goals.

BE ON TIME FOR CLASSES

Students are asked to arrive at least 5 minutes prior to the start of class so they can begin on time. Please be mindful of instructors and other students in the class. Each student has an integral role in the class, and tardiness can negatively impact the ability of other students in the class to learn and grow as a group.



STUDENT SUPERVISION AND SAFETY

At SPAC School of the Arts, the safety and well-being of our students are of utmost importance. Please be advised that school staff are not responsible for the supervision of students in common areas including hallways, lobbies, and outdoor spaces. Children must not be left unattended in these areas at any time. Parents and guardians are responsible for ensuring that their children are supervised before and after classes. Additionally, children are not permitted to enter or attend adult classes under any circumstances.

STUDENT ABSENCES

If you know you will be late or absent from class, please notify the school by emailing school@spac.org or calling (518) 587-3331, ext. 181 (Please leave a message if no one answers.).

EXTENDED ABSENCES

If a student is ill or injured for an extended period (more than two classes), their account may be credited so they may rejoin the class when fully recovered. Students must provide written consent from a physician upon returning.

SICK POLICY

If students have a fever, nausea, vomiting, moderate-to-severe cough or runny nose, or any significant signs of illness, they are asked to stay home and notify the school that they will be absent by emailing school@spac.org.

WAITING AREA USAGE DURING CLASS

Guardians and siblings of registered students are permitted to wait in the common area of the school while their student is taking class. Please be respectful of others by using appropriate volume and language for conversations. Once the class is finished and you pick up your student at their studio door, we ask that you exit the school building so that others can utilize the waiting area while classes are in session.

CLASS CANCELLATION POLICY

If a class is cancelled for any reason (i.e., teacher illness, inclement weather, etc.) students/guardians will be contacted at least 2 hours prior to morning classes and before noon for all afternoon classes. Cancelled classes will be rescheduled or fully refunded.

The cancellation of classes due to inclement weather will be based on the Saratoga Springs City School District.

PRIVATE LESSON CANCELLATION POLICY



If a student cancels a private lesson, they may be given a chance to reschedule, at the instructor's discretion. Otherwise, no refunds, credits, or adjustments will be given if a student misses a lesson for any reason (illness, personal conflict, etc.).

DROP-IN AND MAKE-UP POLICY

Certain classes offer a drop-in option. If a student enrolls as a drop-in, we ask that the student register for class <u>at least</u> 24 hours in advance to ensure they are added to the class roster.

If a student misses their drop-in class, we can offer them a make-up class as a courtesy at the discretion of the instructor. Students must inform the SOTA Administrator of the following prior to class:

- Which class they did not attend
- Which class they intend to take as a make-up (Note: must also be a valid drop-in class within the same discipline and have space available)

TUITION AND PAYMENT

Tuition for registered classes is due at the time of registration. Initial payments must be made prior to the start of the student's first class. Students will not be allowed to participate in classes without completing proper registration and submitting initial payment of tuition. There will be no refunds or pro-rating of paid tuition upon a student's absence or withdrawal from class. Payment of tuition can be made online at the time of registration, in person with cash or a check on the day of the student's first class, OR by mailing a check. SCHOLARSHIPS

Need-based scholarships are available through the application provided on the school's website www.spacschool.org. Scholarships provided with additional support from M & T Bank.

REFUND POLICY

No refunds, credits, or adjustments will be given if a student misses class for any reason (illness, personal conflict, etc.).

WITHDRAWAL FROM CLASS

Notice must be given in writing if a student chooses to withdraw from class. There will be no refunds or pro-rating of paid tuition upon a student's withdrawal.

DISMISSAL FROM CLASS

Student (and legal guardian) understands and agrees that negligent payment or non-compliance on behalf of the student and/or guardian regarding all policies and agreements as detailed on this form could result in dismissal from classes. There will be no refunds or pro-rating of paid tuition upon a student's dismissal.

SCHOOL CONDUCT, GUIDELINES AND RULES



CODE OF CONDUCT

Respect between all teachers, parents/guardians, and peers is always expected. In addition, all are expected to uphold the supportive and non-judgmental learning environment that supports the inclusion of all individuals in the creative process regardless of the individual's race, age, color, weight, national origin, ethnic group, religion, religious practice, disability, sexual orientation, gender identity, or biological sex. Any behavior meant to intentionally threaten this inclusive learning environment (especially behavior that is intentionally disruptive, violent, and/or endangering to others) will not be tolerated and may result in expulsion from the school.

USE OF COMMON AREAS

Noise levels are to be kept at a minimum in the hallways, restrooms, offices, and in the common area outside the studios so as not to disrupt classes in progress. Inappropriate language or topics are not permitted in common areas.

NO SHOES IN STUDIOS

Outdoor shoes are not permitted in the studios unless otherwise specified by school staff or faculty.

NO FOOD, DRINK, OR CHEWING GUM IN STUDIOS

Only water is permitted in studios. Water must be kept in a thermos or bottle with a lid or cap.

NO FILMING OR PHOTOGRAPHY DURING CLASSES

Students and parents/guardians are not permitted to film or photograph any part of classes in studios unless otherwise given express permission from a school staff member.

NO POSTING ON SOCIAL MEDIA WITHOUT PERMISSION

Posting pictures and/or videos to social media that contain children other than your own without permission from a school staff member AND the parent(s) or guardian(s) of the child(ren) pictured is strictly prohibited.

PLEASE WEAR NON-RESTRICTIVE & COMFORTABLE CLOTHING

Traditional dancewear is not required for dance classes unless otherwise specified by the class instructor. Clothing for classes should be as non-restrictive as possible to allow students to move freely.

PERSONAL PROPERTY

SPAC does not accept responsibility for any damage, theft, or loss of personal property in the school building or on school property.

LOCKER USE



Please, do not leave valuables in school lockers. Do not leave anything in lockers overnight. Locks are not provided by the school. SPAC does not accept responsibility for any damage, theft or loss of personal property left unattended in school lockers.

NO SMOKING, ALCOHOL, OR ILLEGAL SUBSTANCE USE

Smoking (including tobacco, marijuana, and vaping) and consumption of alcohol and/or illegal substances is prohibited in all areas of the school property. No person shall use, sell, or promote such products of any kind on school grounds or in the school building.

NO CORPORAL PUNISHMENT

Corporal punishment of any student by any employee for the purpose of punishing that student is expressly forbidden. In unique situations, reasonable physical force may be used to:

- Protect oneself, or any person from physical injury
- Protect the property of the school or others
- Restrain or remove a student whose behavior interferes with the safety and orderly operation of the school, if the student has refused to refrain from further disruptive acts

NO WEAPONS/FIREARMS

Firearms and/or weapons are not permitted on school property. This includes any rifle, shotgun, pistol, revolver, other firearm, knives, dangerous chemicals, explosives, or any object which is not necessary for school activities, and which could be used as a weapon. A weapon is defined as any instrument capable of firing a projectile, the frame or receiver of any such weapon, a firearm muffler or silencer, any explosive device, or any other instrument capable of inflicting bodily harm.

HARASSMENT PREVENTION POLICY

Harassment of any member of the school community (students, parents/guardians, staff) is unacceptable conduct and will not be tolerated. No member of the school community shall be subjected to harassment or discrimination based on a person's actual or perceived race, age, color, weight, national origin, ethnic group, religion, religious practice, disability, sexual orientation, gender identity, or biological sex on school property.

REPORTING AN INCIDENT OF HARASSMENT

Incidents of harassment may be pursued through informal intervention and mediation or through the filing of a formal complaint (complaint forms are available in the reception office). All reports are kept confidential. Students and parents are encouraged to report bullying incidents to the school director.
